### Payments & Policies

**Tuition:** Rates & Fees listed include taxes and are accurate to the date of this document. Visit the school website or contact the school office for the latest rates & fees.

**Rate increases:** For 2025-26, tuition rates have increased by:

- 1%-3% for 0.5-5 hours
- 3%-6% for 5-10 hours
- 4%-8% for 10+ hours

**Registration Fee:** Annual, non-refundable\* fee per student, due upon registration.

**Payments:** Payments monthly in advance by automatic credit card processing (Visa, Mastercard, Amex) or e-transfer. Payments may also be made in full by Visa/Mastercard/Amex, e-transfer or wire transfer. Family discounts are applied to the lower rate tuition when more than one family member has enrolled. Pre-payments must be in place prior to attending class, and to secure enrollment.

- Classes are charged per week based on the number of class hours
- The monthly fee is calculated based on actual classes per week in each month.
- School closure days are excluded from fees, so monthly rates will vary.
- Fees are payable monthly in advance on the 1<sup>st</sup> of each month.

**Taxes:** From 2025-26, GST will be listed as a separate line entry from tuition in customer accounts. Before 2025-26, taxes have always been included in the tuition rates. Note that the Rate Increases noted above already include taxes. The rates have not increased by those percentages plus tax, but only by those percentages.

**Credit Card Merchant Surcharge:** From July 1<sup>st</sup>, 2025, an additional 2.4% merchant surcharge will be added to all payments made by credit card including Visa, Mastercard and Amex. As required by law in Canada, FVAD customers have been given the minimum 30-days' notice of this new charge, and the FVAD card processor and providers were informed of this change. No surcharges occur for payments by debit, interac, e-transfer or cash.

**\*Cancellation:** Dance schools in BC are regulated by the Consumer Protection BC ([consumerprotectionbc.ca](http://consumerprotectionbc.ca)) and as such specific cancellation policies must exist.

- A full refund of any payment (registration fee, tuition or other payment) received in relation to program will be given if a Cancellation Form is received within 10 calendar days of enrolling in that program.
- For cancellation after the initial 10 days, a 30-day written notice of cancellation is required.
- Fees are payable for the 30-day notice period.
- Cancellation forms are available on the Resources page of our school website [fvad.ca](http://fvad.ca).

#### **No Costume or Choreography Fees**

- Our tuition covers all costumes and choreography for students to perform in school and community performances.
- Additional entry fees may apply for festivals.
- Students not enrolled in the recommended ballet classes for their level may have an additional performance fee for the year end. Families will be informed prior to committing to the performance.
